Guidelines for the Awards

1. Innovative Regional Queensland Planning Solution Award

1.0 Background

Following the 2022 Awards Evaluation Report recommendations, it was proposed to update the format of one of the categories for the awards. The initiative stems from the premise to incorporate a more interactive, student driven format. It was decided this format would continue for 2025 under a new category being the *Innovative Regional Planning Solution*.

This category invites university students to outline (individually or in teams of up to three students) the solution to a specific Queensland regionally based planning problem of their choosing. Their submissions will present the planning issue and their proposed solution to a panel of Planning Group executive officers including the State Planner.

This award is open to undergraduate, post-graduate and masters planning students.

Students from the following universities can nominate themselves for this award:

- University of Queensland (UQ)
- Queensland University of Technology (QUT)
- Griffith University
- University of Southern Queensland (USQ)
- University of the Sunshine Coast (USC).

1.1 Award

One overall award is presented to an outstanding student or team of students, with up to two highly commended runner ups also recognised.

The winner will be the submission which presents a solution to a regional Queensland planning problem that is considered innovative, practical, original, and scalable.

This award is intended to:

- publicly recognise innovative and practical approaches to real regional Queensland planning problems
- attract the brightest and best students
- stimulate passion and engage students to employ their skills and creativity
- generate exciting ideas, innovation and collaboration to produce new, fresh and scalable ideas connected to address a regionally based planning challenge.

The winner/s of this category will receive a paid internship with the Department of State Development, Infrastructure and Planning (the Department). The winner/s may be included in a media statement and their submission presented in our website.

The name of the prize-winning nominee/s and university they attend may be published. However, no additional personal information will be given out without the prior consent of the prize-winning nominee/s.

The award will be presented during the annual Planning Industry of Australia (PIA) 2025 Queensland Awards for Planning Excellence, to be held on 7 November 2025.



1.2 Assessment criteria

Weighted Criteria	Weighting
Presenting a 'regional' planning solution or opportunity to a problem: The regional problem is a 'real regional Queensland' issue, and the solution is innovative and contributes to communities being well-planned, prosperous, resilient, and sustainable.	60%
Practicality: The solution to the regional problem also illustrates how it can be implemented. It is practical to the work of planning practitioners.	20%
Readability (written submission): Ideas and arguments are presented logically and clearly, assessed from the point of view of a planning practitioner.	10%
Compelling (<i>live or virtual presentation</i>): Presentations to the judging panel are knowledgeable, well organised, engaging, and delivered with conviction.	10%

Mandatory Criteria

Original work: The submission needs to be the students' original work, except for any permitted third-party material, and has not been published elsewhere.

Permitted third-party material: The thesis or study does not include any third-party material unless it is appropriately used, acknowledged and referenced in accordance with standard academic practice and copyright law.

1.3 Entries

Students from all the eligible universities may nominate their own entry if they consider it meets the above criteria.

Compelling (<i>live or virtual presentation</i>): Presentations to the judging panel are knowledgeable, well organised, engaging, and delivered with conviction.	10%

3. Young Trailblazer in Planning Award (university nomination)

3.0 Background

The Young Trailblazer in Planning Award will be presented to one university undergraduate (second, third or fourth year) recognised as being a student who has demonstrated exceptional promise, vision and creativity in the field of planning.

The Department invites universities to nominate up to three students for consideration.

The following universities can nominate students for this award: UQ, QUT, Griffith University, USQ, and USC.

The award is only open to university nomination. Students may not nominate themselves for this award.

3.1 Award

One award will be presented to a student who meets the criteria outlined below.

The winner will be chosen based on a rationale (750 words maximum) submitted by their university that addresses the assessment criteria.

The winner will be offered a four-week paid internship with the Department, subject to the Department's standard engagement conditions and criteria.

The award is intended to:

- acknowledge a young professional not only for their professional achievements but also their potential to shape the future of planning
- give students the opportunity to develop an understanding of the state's role and contribution to planning early in their career and appreciate their positive impact as a planner in Queensland in shaping the places where we live, work and play.
- increase the future pipeline of qualified planning professionals to address the severe shortage of planners in Queensland
- strengthen links between universities and the Department.



The name of the prize-winning nominee and university they attend may be published. However, no additional personal information will be given out without the prior consent of the prize-winning nominee.

The award will be presented during the annual PIA 2025 Queensland Awards for Planning Excellence, to be held on 7 November 2024.

3.2 Assessment criteria

This award will be given to a student who displays one or more of the following characteristics:

Criteria

Outstanding results in the study of planning at undergraduate level during the current academic year (2025).

Involved in a planning student association that is enhancing the experience of planning students at the university.

Shows promise of high achievement in the planning field.

3.3 Entries

Each university is invited to nominate up to three students who meet one or all of the above criteria.
