Notice about the process for amending a planning scheme under section 18(3) of the *Planning Act 2016*

Proposed Planning Scheme Amendment No.17 (Tailored Amendment – Bundaberg Health and Enterprise Precinct) - Bundaberg Regional Council

Introduction

This notice is given by the Chief Executive of the Department of State Development, Infrastructure and Planning (the Department) administering the *Planning Act 2016* (the Planning Act) in accordance with section 18(3) of the Planning Act, with respect to the planning scheme amendment proposed by the Local Government (proposed amendment) by way of notice under section 18(2) of the Planning Act.

Part A of this notice sets out the steps undertaken for the planning and preparation of the proposed planning scheme amendment prior to the issuing of this notice. Parts B & C of this notice set out the process that applies to the proposed amending of this planning scheme, and the entity responsible for each step in the process¹.

The process stated in this notice must be followed by the Local Government in accordance with section 18(6) of the Planning Act.

1. Chief Executive Powers and Functions

The Chief Executive delegates under section 282 of the *Public Sector Act 2022* the functions and powers of the Chief Executive under this notice to the following delegates:

1.1 For Chief Executive functions and powers listed in Part B of this notice:

- (a) Deputy Director-General, Planning Group
- (b) Executive Director, Planning Group
- (c) Director, Planning Group
- (d) Manager, Planning Group

1.2 For Chief Executive functions and powers listed in Part C of this notice, the person stated as the delegate for each step in Column 4 of Table 2.

Chief Executive delegations exclude the power to subdelegate.

¹ Where the functions and powers of the Chief Executive under this notice may be appropriately performed or exercised by an officer in Planning Group in the Department, this notice includes the delegation of the Chief Executive.

Part A – Planning and preparation

Early and ongoing engagement with the State Government and other stakeholders identifies and helps address issues early in the plan-drafting process.

Table 1 sets out the steps that the Local Government has advised the Chief Executive have been undertaken for the planning and preparation of the proposed planning scheme amendment prior to the issuing of this notice.

Part B – General process provisions

This part prescribes matters that are to be read in conjunction with the requirements set out in Part C.

1. Requesting information and changes

- 1.1 The Minister for Planning (Minister) or Chief Executive, as relevant to the process, may, at any time, give the Local Government a notice:
- (a) requesting further information; or
 - (b) advising of any changes to the proposed planning scheme amendment to address State interests.

2. Managing timeframes

- 2.1 The Minister, Chief Executive, or Local Government, may pause a timeframe (except for the public consultation timeframe) for an action for which the entity is responsible, by giving notice to the other entity prescribed in the relevant section of the process. This notice must state the period for which the timeframe will be paused and a date upon which the timeframe will restart.

- 2.2 If a notice to pause a timeframe is given, the process is paused from the day³ after the notice is given until the date stated in the notice, unless the notice is earlier withdrawn by the party that gave the notice.
- 2.3 If a notice to pause a timeframe is withdrawn, the process restarts from the day after the withdrawal notice is given.
- 2.4 The duration of a pause notice may be extended by the giving of another pause notice before the paused period ends.
- 2.5 Each entity may only pause timeframes for steps for which it is responsible under Part C of this notice for a cumulative total number of days as follows:
 - (a) for the Minister and the Chief Executive, collectively a total of 45 days; and
 - (b) for the local government, a total of 45 days.
- 2.6 A timeframe may be paused beyond the cumulative total number of days stated in Section 2.5 where the Local Government and either the Minister or Chief Executive, whichever entity is relevant to the current part of the process, agree that it is appropriate to pause the timeframe for a further agreed number of days.

3. Public consultation

For public consultation included in Part C of this notice, the local government is required to comply with the following:

- 3.1 Publish at least one public notice about the proposal to amend the planning scheme.
- 3.2 Keep the proposed planning scheme amendment available for inspection and purchase for the duration of the consultation period identified in Part C of this notice.
- 3.3 The public notice must:
 - (a) be in accordance with the requirements stated in the definition of 'public notice' in schedule 2 of the Planning Act;
 - (b) state the consultation period identified in Part C of this notice; and
 - (c) state that any person may make a submission about the proposed planning scheme amendment to the Local Government within the consultation period.
- 3.4 Consider all properly made submissions about the proposed planning scheme amendment.
- 3.5 Notify persons who made properly made submissions about how the Local Government dealt with the submissions.
- 3.6 For the public consultation report, a notice containing a summary of the matters raised in the properly made submissions and stating how the Local Government dealt with the matters must be given to the Minister.
- 3.7 If consultation is required to be repeated due to a significantly different change (having regard to the definition in the Minister's Guidelines and Rules (MGR), including reference to schedule 2 of the MGR), the Local Government may decide to limit the public consultation to only those aspects of the proposed planning scheme amendment that have changed.

4. Communications strategy

The Local Government is required to implement the communications strategy about the proposed planning scheme amendment at Appendix A.

5. Changing the proposed planning scheme amendment

- 5.1 The Local Government may make changes to the proposed planning scheme amendment or propose conditions the Minister or Chief Executive may consider imposing.
- 5.2 The Local Government must ensure any changes made to the proposed planning scheme amendment continue to appropriately integrate and address relevant state interest/s, including those identified in a State interest review.
- 5.3 Where a change results in a version of the proposed planning scheme amendment that is significantly different (having regard to the definition in the MGR, including reference to schedule 2 of the MGR) to the version released for public consultation, the Local Government must restart the consultation process as outlined in Part C.
- 5.4 However, the Chief Executive may determine that Section 5.3 does not apply for a change that is significantly different, if the change addresses an issue raised in submissions or addresses a matter raised during State interest review.
- 5.5 At any time the Chief Executive may consider giving to the Local Government an amended notice about the process for amending the planning scheme, in accordance with section 18(3)(b) of the Planning Act.

Part C – Process for amending the planning scheme

Unless stated otherwise, the process described in this Part C is to be undertaken in the order in which it is prescribed in Table 2. The proposed planning scheme amendments will be informed by the steps taken under Part A. This does not preclude the need for steps to be repeated should changes be made to the proposed amendment, as provided for in Part B.





1.0 Introduction

Council has drafted an amendment to the Bundaberg Regional Council Planning Scheme to incorporate local planning for the Bundaberg Health and Enterprise Precinct. The Council intends to progress this planning scheme amendment using the tailored process for plan-making established under section 18 of the *Planning Act 2016* (the Act).

This strategy has been developed to support statutory requirements for public notification under the Act, taking guidance from the *Community engagement toolkit for planning*.

This strategy identifies relevant stakeholders for involvement in public consultation, representing stakeholders that are either affected by this proposed amendment or have the potential to influence outcomes of the drafting process.

Exploring stakeholder interests, concerns and influence, this strategy aligns appropriate community engagement tools to each stakeholder to ensure that public consultation is inclusive, accessible and appropriate to the intended audience.

Finally, this strategy provides an implementation plan for community engagement activities being undertaken during the public notification period.

1.1 Tailored approach – Statutory Requirements and Timing

Council intends to progress this planning scheme amendment using the tailored process for plan-making established under section 18 of the Act.

Pursuant to section 18 of the Act, after the local government gives notice about the proposed amendment to the Chief Executive, the Chief Executive must give a notice (or amended notice) to the local government specifying the process for amending the planning scheme.

This notice, or amended notice, must state at least—

- a) the local government must publish at least 1 public notice about the proposal to make or amend the planning scheme; and
- b) the local government must keep the instrument available for inspection and purchase for a period (the **consultation period**) stated in the public notice of at least—
 - i) for a proposed planning scheme—40 business days after the day the last public notice is published; or
 - ii) for a proposed amendment—20 business days after the day the last public notice is published; and
- c) the public notice must state that any person may make a submission about the instrument to the local government within the consultation period; and
- d) a communications strategy that the local government must implement about the instrument; and
- e) the local government must consider all properly made submissions about the planning scheme or amendment; and
- f) the local government must notify persons who made properly made submissions about how the local government dealt with the submissions; and
- g) the local government must give the Minister a notice containing a summary of the matters raised in the properly made submissions and stating how the local government dealt with the matters; and
- h) after the planning scheme is made or amended, the local government must publish a public notice about making or amending the planning scheme.

This communications strategy aligns with these statutory requirements for public notification. It is proposed to undertake state interest review and public notification concurrently.

2.0 Communications Strategy

Community engagement is important for ensuring that planning decisions reflect the best interests of the community. By engaging appropriate stakeholders, Council can receive meaningful feedback about the proposed amendment during the public consultation period.

2.1 Purpose

The purpose of this communications strategy is to: -

- Provide relevant information to the Chief Executive regarding the communications and engagement approach Council will assume to undertake public notification in accordance with statutory requirements;
- Identify relevant stakeholders, including their underlying interests, potential concerns and their contribution to the public notification process;
- Outline the strategy for community engagement for the delivery of this consultation plan;
- Facilitate informative and meaningful engagement with relevant stakeholders.

2.2 Objectives of Stakeholder Engagement

The overarching objectives of this communications strategy are to: -

- Engage with identified project stakeholders regarding the proposed amendment, selecting engagement tools that are appropriate and meaningful;
- Ensure that affected landowners and the community are adequately informed about the proposed amendment and can provide feedback about the local planning outcomes;
- Enhance community acceptance of final decisions and resultant outcomes through appropriate engagement processes;
- Strengthen relationships between Bundaberg Regional Council and project stakeholders;
- Engage in mutual learning where concerns raised in consultation are considered through the amendment process, facilitating informed and transparent decision-making;
- Meet statutory obligations of Bundaberg Regional Council, and other regulatory bodies.

2.3 Preliminary Stakeholder Engagement

In 2024, the Queensland Government engaged Urbis to complete a Concept Master Plan for the land surrounding the new Bundaberg Hospital being built at Thabeban. This Concept Master Plan sought to maximise economic opportunities for the region by facilitating a high quality health and education precinct surrounding the hospital. This project involved engagement with the local government and various state agencies.

Council engaged Mewing Planning Consultants Pty Ltd in October 2024 to progress concept masterplanning completed by the Queensland Government, preparing a local plan (draft planning scheme amendment package) for the Bundaberg Health and Enterprise Precinct. Prior to preparation of this local plan, the consultants undertook preliminary targeted engagement with landowners, Bundaberg Brewed Drinks, Economic Development Queensland, Department of State Development Infrastructure and Planning, Friendly Society Private Hospital Bundaberg, Mater Private Hospital Bundaberg, and Queensland Health (Wide Bay Burnett Hospital and Health Service).

The draft planning scheme amendment package was sent to the two main landowners within the local plan area on 22 May 2025 and the Queensland Government (DSDIP, WBBSARA, Queensland Health, DTMR) on 16 June 2025 for preliminary feedback prior to commencing the formal planning scheme amendment process. Feedback was received from consultants on behalf of the two key landowners, resulting in some changes to the amendment package.

2.4 Stakeholder Identification

For this planning scheme amendment community consultation will involve a range of community and industry stakeholders who are likely to be affected by this proposed amendment or have the ability to influence decision making. The following stakeholders have been identified as relevant to the proposed amendment: -

- Department of State Development, Infrastructure and Planning
- Department of Transport and Main Roads
- Department of the Environment, Tourism, Science and Innovation
- Department of Health (Queensland Health) - Wide Bay Hospital and Health Service

- Adjoining landowners of the Bundaberg Health and Enterprise Precinct
- Bundaberg Brewed Drinks
- The Port Curtis Coral Coast Group (PCCC)

- Development industry, including local developers, consultants and the Bundaberg Branch of the Urban Development institute of Australia (UDIA)
- Private Hospitals throughout the Bundaberg Region
- Central Queensland University
- TAFE Bundaberg
- The broader community

While this list considers stakeholders that are most likely to be affected by the proposed amendment, this list is not exhaustive and is subject to additional consultation if unanticipated public concern and feedback is received.

State agencies will be consulted through State interest review.

2.6 Level of Engagement

The appropriate level of community engagement for the implementation and delivery of this communications strategy is to inform and consult stakeholders, as per the IAP2's Public Participation Spectrum.

Consistent with IAP2's Public Participation Spectrum, to effectively inform and consult stakeholders the following promises are made to the community: -

- *'We will keep you informed, listen to and acknowledge concerns and aspirations, and provide feedback on how public input influenced the decision.'*
- *'We will seek your feedback on drafts and proposals'* (International Association for Public Participation, n.d).

This level of engagement is considered most suitable for the proposed amendment, providing balanced and objective information to relevant stakeholders about the nature of proposed changes and the importance of this local planning, and ensuring that the final amendment adequately considers the concerns and interests of stakeholders.

3.0 Implementation Plan

Table 3 outlines the community engagement tools that will be used throughout the public notification period for the proposed planning scheme amendment, considered appropriate for reaching out to affected stakeholders, informing the public and allowing the community to have a say about this local planning surrounding the new Bundaberg Hospital.

Engagement tools will aim to effectively achieve the following outcomes: -

- Raise awareness of the draft planning scheme amendment;
- Provide accessible and accurate information to the public;
- Seek submissions on the draft planning scheme amendment;
- Engagement with specific communities and stakeholders; and
- Hear concerns and issues raised by the community.
